

ONE YEAR LIMITED WARRANTY

Green It Now Inc. dba Green Leaf Doors warrants its products sold under this warranty to be free of defects in materials and workmanship which would render them unserviceable for their ordinary use for a period of 1 year from the date of purchase from the manufacturer or any dealer purchasing doors directly from Green It Now Inc. All doors must be properly handled, finished and installed per manufacturers instructions. See handling, finishing and installation guidelines. Doors are only warranted that are stored and installed in locations protected from exposure to direct sun or rain under normal conditions.

Limitation of Liability

Green It Now inc. dba Green Leaf Doors shall not be liable for incidental, indirect or consequential damages arising from the manufacture, use, or sale of these goods. Green It Now Inc's liability is expressly limited to the repair or replacement of non-conforming goods or the refund of the purchase price after return of the product, less freight cost, at the option of Green It Now Inc. Green It Now Inc. is not liable for the finishing or installation of any replaced goods.

Exclusions From Warranty

Since methods and conditions of installation and use are beyond the control of the manufacturer, this warranty is not effective unless the doors are handled according to the attached handling instructions. The following items are not defects in workmanship or material and are not covered by this warranty.

- Modifications, alterations (including trimming and cutting down door), repair or service of this product by anyone other than manufacturer or someone authorized by the manufacturer to do so.
- 2. Any use of the product other than for which it was intended.
- Door warp, unless it exceeds 1/4" in the plane of door, whether cup, bow or twist. Doors in excess of 7'-0"(2 1/4" thick doors in excess of 8'-0") tall are not warranted against warp of any kind.
- Variations in wood color, texture, pattern and/or grain are not considered defects and are not covered by this warranty.
- Any defects or damages arising out of, or resulting from, intentional misuse, human act, act of God, or any other circumstances beyond the control of the manufacturer.
- Scratches, abrasions, or other damage caused by improper handling and cleaning.
- 7. Damage caused by attempts other than Green It Now inc's attempt to repair door.

- 8. Failure to properly seal the door. All edges must be sealed within 72 hours after fitting and hanging with the integrity of the finish maintained.
- Damage caused by improper handling or onsite storage.
 Storage damage includes moisture in doors due to humidity.
- 10. Doors must be pulled and removed from the jobsite during Drywall mudding, interior plaster or other form of wall finish that requires additional moisture. This includes work preformed by other trades that include excessive moisture.
- 11. Panel misalignment or shrinkage is not considered a defect.
- 12. The performance or appearance of finishes applied is not covered.
- Expansion of bottom rail due to climate conditions is not considered a defect.
- 14. Failure to perform normal homeowner's maintenance, including maintaining finish. This includes washing doors with excess moisture.
- 15. Doors must be stored in a conditioned space after receiving. Do not store doors in a basement.

Notice Requirements

Since Green It Now Inc. cannot control the handling or exposure of doors after shipment, a specific duty of inspection is imposed upon the purchaser as a condition to any claim under this warranty. Such inspection must be made upon receipt of product and Green It Now inc. must receive written notice of any claim within 10 days of receipt of product.

Limitations And Exclusions

Each of these warranties shall be void and Green Leaf Doors shall have no liability hereunder if the end-user installs, treats or retains, for more than thirty (30) days, a door containing an obvious defect, without giving the notice as required herein, or if the end-user fails to give the required notice within a reasonable time after discovery of a latent defect. Proof of purchase, including the original purchase date, is required for warranty service.

There are no express warranties, which extend beyond the foregoing and any implied warranties, including warranties of merchantability and fitness for a particular purpose, are limited to the same duration as the written warranty (one year from the date of shipment by Green It Now inc. for exterior and fire doors).
